The company has an experienced Security Technician on a daily basis and an Occupational Doctor who makes visits according to the legislation.

AGRO.VI.M S.A. recognizes the worker's duty to identify hazards, and supports and encourages workers to play an active role in identifying hazards and to offer suggestions or ideas to improve the health and safety program.

Management supports participation in the program by all employees and provides proper equipment, training and procedures. Employees are responsible for following all procedures, working safely, and, wherever possible, improving safety measures.

Occupational health and safety are defined by the Management of **AGRO.VI.M S.A.** as ensuring the well-being of employees and also of any other person in its field.

This is achieved through:

- ✓ recognition and assessment of all possible risks arising, both from the performance of work (regular and non-regular), and from any other activity of staff who have access to the workplace, including visitors (external collaborators, trainees, etc).
- ✓ providing a positive safety culture in which every employee, contractor and visitor feels free to speak up about non-conformances, undesirable or unsafe situations
- ✓ the effort to minimize the likelihood of a risk occurring and also its impact, in case it cannot be avoided, by implementing appropriate procedures and measures for prevention and protection
- ✓ compliance with applicable occupational health and safety legislation
- ✓ having a risk-based process in place for the identification, classification, prioritization and control of hazards and risks
- ✓ the assessment and measurement of the risk at regular intervals and in particular after the implementation of corrective and / or preventive actions, in order to ensure its continuous reduction
- ✓ the provision of all required resources (staff training, personal protective equipment, markings, fire protection means) to safeguard the safety and health of workers

The Management of **AGRO.VI.M. S.A.** undertakes to continuously monitor its performance on health and safety issues and to aim for continuous improvement of its performance.

The increasing consciousness and awareness of its staff and stakeholders (partners, customers, suppliers, etc.) through continuous information and training in Occupational Health and Safety issues, is one of the most important goals of the company's Management.
